

red24 Terms Of Website Use

The following terms apply to the usage of the red24 website <http://www.red24.com>. This website is owned and operated by red24 plc (hereinafter referred to as 'We', 'Our' and 'Us'), which includes both red24 Sales Limited and red24 CRM (Pty) Ltd. Details of our registered office addresses and VAT number are set out at the end of this document. By using our website, you indicate that you accept these terms of use and that you agree to abide by them. If you do not agree to these terms, please do not access or use the website.

Access

Access to our website is permitted on a temporary basis. We reserve the right to withdraw, limit or amend access rights without prior notice (see below).
